Contributions from corporations, labor organization treasury funds, foreign nationals and federal government contractors are prohibited. Corporations and individuals are strictly prohibited from reimbursing another person for making a contribution to **Amy McGrath for Senate**.

To comply with federal law, we must use our best efforts to obtain and report the name, mailing address, occupation, and employer of all individuals whose contributions aggregate in excess of \$200 per election cycle.
